***INSTRUCTIONS FOR PRESENTATIONS TO THE PAC BY PARENTS AND CITIZENS***

*Journey School welcomes your participation at the school's Parent Advisory Committee (PAC) meetings. To assist you in the ease of speaking/participating in our meetings, the following guidelines are provided:*

- 1. Agendas are available to audience members during the meeting and posted on school campus and posted on the school website.*
- 2. "Request to Speak" cards are available for all audience members who wish to speak on any agenda items or under the general category of "Public Comment." "Public Comment" time is set aside for members of the audience to raise issues that are not specifically on the agenda. However, due to public meeting laws, the PAC can only listen to your issue, not discuss your issue, respond in substance or take action. These presentations are limited to five (5) minutes (ten (10) minutes if a translator is needed) and total time allotted to non-agenda items will not exceed thirty (30) minutes.*
- 3. With regard to items that are on the agenda, you may specify that agenda item on your "Request to Speak" card. Following the presentation on that agenda item by staff, school committees or the public, the President/Chairperson of the PAC will recognize members of the public who have submitted a "Request to Speak" card. This period precedes PAC discussion. You will be given an opportunity to speak for up to five (5) minutes (ten (10) minutes if a translator is needed).*

4. When addressing the PAC, speakers are requested to state their name and adhere to the time limits set forth.
